V-CAP, Politics & Union Dues: How Does it Work?

The UAW's V-CAP check off is a voluntary program that allows each member to make a modest contribution each month to help their union support candidates who care about American workers and their jobs.

By law, Union dues **cannot** be used to support any Federal candidate, and in an ever-increasing number of states, any candidate for public office. Our only means of monetary support for many Labor-endorsed candidates is voluntary political contributions which are put into the International Union's Political Action Fund, UAW CAP.

As the political arm of the Union, CAP's task is to educate, organize and mobilize active and retired UAW members to protect our interests at the ballot box and in the legislative arena.

For what political offices does the local endorse candidates?

Locals generally work through the UAW Community Action Program structure to endorse candidates for any elected office. They work in city, county, area or state CAP councils and are involved in the endorsement of statewide or local officials, US representatives and US senators.

Why don't more workers support labor-endorsed candidates?


Sometimes workers make their selections based solely upon a candidate's position on single "hot button" non-labor issues. That candidate, however, will vote on many more issues than just that one. Be careful.

Protecting our collective bargaining gains through political action should be a priority of every UAW member.

Why Labor is in Politics?

Labor Unions have always been under constant attack from business, industrial organizations and often from state and national legislatures and political leaders. Every time the US Congress or a state legislature opens a new session, a flood of bills intended to restrict the rights of workers and their families are introduced.

Workers have learned through bitter experience that there is a powerful link between the bread box and the ballot box. Gains won at the bargaining table or through sacrifice on the picket line can be wiped out by unwise actions of state or national legislatures and political leaders — that today's wage increase can be erased by taxes or inflation, or your job vanish in a wave of unemployment. Thus, unions are in politics to protect the welfare and security of their members.



Grievance Update

148 grievances filed so far in 2018.

The last arbitration hearing was on April 13, 2018 (outsourcing policy grievance).

The Bargaining Committee continues to work with the company to schedule arbitration dates.

Grievance Backlog Settlements

Members of the Bargaining Committee have been diligently working for the past several weeks in reaching agreements for settlement on the backlog of grievances with the company.

Regarding overtime: 1,046 grievances were settled; 425 employees will be back paid.

Regarding recall displacement: 400 grievances settled so far; 225 employees will receive back pay.

The Bargaining Committee is currently working on bringing 18 terminated employees back to work.

They will strive to settle more grievances down the road.

Union Stewards, First to Be Asked

Many questions you bring your steward, or problems vou raise, can be dealt with satisfactorily without any type of formal action being taken by the union. It may be that information is the "fix" that's needed, or a conversation between your steward and a management official solves the problem. But sometimes a steward will set in motion a formal action, the most common type being a contract grievance. If the problem or concern that you have calls for a grievance to be filed, then your steward is mostly likely the "minilawyer" who will help draw up and present the grievance and attempt to get it resolved. Your steward may take another type of action, as well, to assist you. Your steward is the one with overall responsibility for answering questions about what the employer or the union is doing or could be doing to make things better in the workplace. If the union cannot do something to bring about positive change, your steward should be able to explain why that is.

Working Class Under Attack

Janus v. AFSCME
Supreme Court
Decision: The Supreme
Court ruled 5-4 in June
2018 that nonunion
workers cannot be forced
to pay fees to public
sector unions to cover the
costs of collective
bargaining.

NLRB ruling: On May 21, 2018, the U.S. Supreme Court ruled that employers can use arbitration clauses in employment contracts to bar employees from filing class-action lawsuits related to wage and overtime claims. In a 5-4 split decision, the court determined that employment agreements can require arbitration, waiving the employee's right to participate in a class-action lawsuit, to settle these disputes.

Trump Administration kill a regulation: The Labor Department has rescinded what is known as the "persuader rule," a 2016 reform that required businesses to publicly disclose more information about the union-busting consultants they hire.


Retiree Summer Picnic: A Success!
