Update from Brian Hulbert, Vice President of UAW Local 578

Hello, members!

I would like to give an update on what is presently going on with the grievance procedure at the local.

The A/S arbitration is currently in the final stage of the federal court. Our attorney will be submitting the final brief the week of December 1, 2020.

We are waiting for the ruling on the arbitration regarding the arbitration regarding July 4th. That should be arriving in the upcoming weeks.

We will be scheduling arbitration for five (5) terminated employees within the next month.

We will also be scheduling arbitration regarding mandatory overtime.

During the COVID-19 pandemic, we have worked with the company to get nine (9) employees back to work without going to arbitration. That brings the total to 61 employees in the last 3 1/2 years.

We will be submitting another term proposal to the company after our next arbitration screening early in January.

A steward election was held on November 4, 2020. The stewards were sworn in on November 30, 2020. Training will take place in December 2020.


#### **Contract Negotiations**
